In the spring of 2025, the Hiedanranta Visitor and Cultural Center will open in Lielahti Manor, offering premises for artists, cultural producers, and creative industry operators, as well as enabling communal and self-directed cultural activities such as various events, performances, exhibitions, and workshops, along with high-quality ancillary services for all city residents. A new artist and cultural community will also be formed at the manor. The interim space applicant is expected to provide ideas or proposals for collaboration with the manor's activities and community in their application. Floor plan


